Arizona state chapter recognized for outstanding member communication

Due to these efforts, the chapter achieved a high attendance rate for regular meetings and saw a significant increase in membership last year.

"We take our membership needs very seriously," said Liliana Davalos, NATP Arizona chapter president. "We saw the need for education in our state and worked hard to implement those topics. Sharing practice management topics and state topics generate interest in our education sessions. Additionally, we're one of the first chapters to offer Spanish classes."

New York took second place due in part to its frequent chapter meetings and communications. The New York chapter is known for offering outstanding education throughout the state and received the maximum number of points for member communication. New Jersey's ability to



host members at events, including education and social events, played a large part in securing third place.
