"We couldn't have asked for more deserving winners of this year's awards," said Amanda Schumacher, NATP chapters program manager. "Both Brad and Melissa, and the Georgia and New York chapters, have made a significant difference in their communities, and the broader tax industry as a whole."

Messner is a third-generation owner of M&J Tax Services in Pennsylvania. He started working part-time at the family business when he was 16. After 27 years in the industry, Messner said the best advice he can give to new preparers is to integrate themselves into an industry organization and find peers who you feel comfortable with.

"The coolest thing about being nominated for this is, for a lot of us, we work in our own businesses, our own silos," Messner said. "It feels great to be appreciated by people recognizing what I'm doing, not just in but outside of my own little organization here. It's easy to get bogged down in our daily operations and to have people recognize that I've kind of gone above and beyond is really cool."

Lewis has been in the tax industry for 32 years and is a co-owner of Vinny Lewis' Business Solutions in Wichita Falls, Texas, and an NATP member since 2006. She currently serves on the Texas chapter board as treasurer.

"I am always proud of the NATP Texas chapter," Lewis said. "I feel that we try to go above and beyond to help our members get the education they need while still giving back to our community. This year, we started Texas Tax Tuesday Talks to try to reach more members and help each other with problems they have with clients, the IRS or even in their office."
