From the Education Chair

There are so many things happening on the Education front, we decided to use this edition of the newsletter to focus on all the education occurring this year!

In this issue:

Enrolled Agent Exam Review Course! Are you looking to take the EA Exam? The NY Chapter is offering NATP's famous EA Exam Review Course in two great locations: Cicero NY (near Syracuse, I-81 and I-90 and just minutes from the Syracuse airport) and Rockville Center (right on Sunrise Highway, Rt 27, directly below the Rockville Centre station of the Long Island Railroad, easily assessable from the Amtrak NYC station, just a \$50 cab ride from JFK airport). Led by three great instructors, these sessions will provide personalized assistance, a networking lunch and a one hour informal question and answer after the first and second day sessions! Nuts & Bolts of Trusts

Trusts are everywhere. While once a vehicle for the affluent, these days more and more clients are looking to trusts to protect them and their assets. Every day, clients ask tax professionals about a trust. How is this treated? How is that treated? Above it all, the tax ramifications loom! This session takes you through the how, why and what if's behind trusts, including the Form 1041 This Nuts & Bolts seminar, written by an attorney who also runs an active tax practice, is the essential seminar on Trusts. Level: Basic. IRS Program Number is SC1N9-T-00018-15-I and qualifies for eight (8) CE in federal tax law.

Preparing S Corporation Returns

This course is for both the inexperienced and experienced tax professional to get up to speed on the most common areas of S corporation taxation and for tax professionals looking to include the preparation of S corporation income tax returns in their business. 

Have you been considering taking the EA Exam?

The NY Chapter has you covered!
We will be offering a three (3) day EA Exam Review Course this September in two locations!

This three (3) day hands on course is designed to help you prepare for and pass all three (3) parts of the Special Enrollment Examination (SEE). The information in this course is referenced to the Internal Revenue Code as amended through December 31, 2014, and is applicable for those taking the exam between May 1, 2015 and February 28, 2016.

With three instructors, attendees can expect hands on, personalized attention. In addition, After Day One and Two, there will be a one hour "Ask the Instructor" period

- ❖ Assess information from the prior year return to thoroughly report current year information.
- ❖ Identify criteria that require an individual to file an income tax return to comply with federal law.
- ❖ Determine if a person meets the definition of a qualifying child or a qualifying relative so the taxpayer can claim the person as a dependent.
- ❖ Identify items of reportable income and expenses for individual taxpayers.
- ❖ Calculate taxable income from retirement plan or IRA distributions to provide the taxpayer with maximum basis recovery.
- ❖ Differentiate between a refundable credit and a nonrefundable credit to provide the taxpayer with the minimum tax due.
- ❖ Categorize the sale or disposition of assets to properly classify and report gain or loss.
- ❖ Explain the tax consequences of gifting either cash or property.
- ❖ Identify the primary filing obligations in regard to a deceased taxpayer.
- ❖ Differentiate between different types of business structures to assist taxpayers in choosing a business entity.
- ❖ Categorize business income and business expenses for proper reporting.
- ❖ Calculate asset depreciation to account for wear and tear on assets.
- ❖ Distinguish items that affect basis in the entity from items that do not affect basis so that business losses are properly allowed.
- ❖ Explain how tax requirements and limitations affect business tax planning.
- ❖ Analyze business records to adhere to recommended recordkeeping procedures.
- ❖ Analyze trust documents to determine appropriate filing procedures.
- ❖ Describe provisions unique to farmers and other specialized taxpayers
- ❖ Differentiate between different types of business structures to assist taxpayers in choosing a business entity.
- ❖ Summarize what constitutes practice before the IRS.
- ❖ Identify who is authorized to practice before the IRS.
- ❖ Distinguish what constitutes a sanctionable act as related to duties and restrictions on practice before the IRS.
- ❖ Identify supporting documentation and legal authority that can strengthen a taxpayer's position.
- ❖ Identify types of taxpayer tax information available in transcripts from the IRS.
- ❖ Explain to a taxpayer the various tools available in countering the IRS collection process.
- ❖ Apply safeguards to comply with recordkeeping and records maintenance requirements while at the same time maintaining taxpayer confidentiality

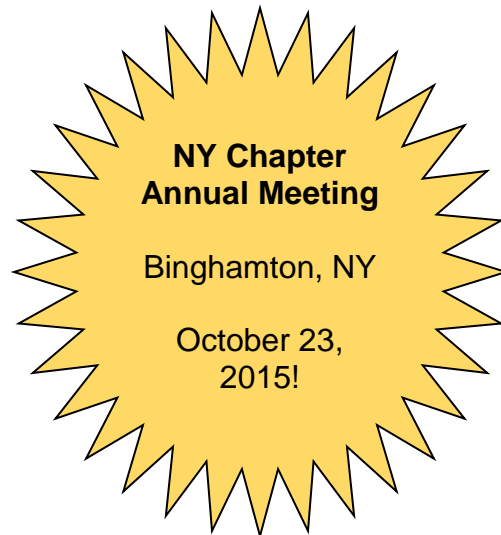
