REMINDER from NYS Dept of Tax & Finance

Do I need to Register with NYS?

You **must** register, or renew your registration, with the New York State Tax Department for every calendar year in which you:

- will be paid to prepare **ONE OR MORE** New York State tax returns or reports; or
- will facilitate a refund anticipation loan (RAL) or refund anticipation check (RAC).

Am I exempt from Tax Preparer Registration?

To determine if you are required to register, pay the registration fee, and take continuing education courses, please answer the question below.

Are you one of the following?

- Attorney
- CPA (certified public accountant)
- PA (public accountant)
- Enrolled Agent
- Volunteer tax preparer
- Employee of an attorney
- Employee of a CPA
- Employee of a PA
- Employee of an enrolled agent
- Employee of a business who prepares that business' tax returns

If you are one of the licensed professionals or other individuals listed above, you are **NOT** required to register as a **tax return preparer and are NOT required to take Continuing Education courses**.

As of the printing of this newsletter, the 2018 NYS
Preparer Continuing Education
Program has not be released.

As soon as they become available, the NY Chapter will alert you!

If you are NOT one of the above, you MUST REGISTER or renew and take the courses listed on the next page!

Do you administer RALs or RACs?

Yes. If you administer RALs or RACs, you **must** register as a facilitator. See <u>How to register as a tax preparer or facilitator</u> to learn how.

Continuing Education Requirements For Tax Return Preparers

Who must complete requirements

If you meet New York State's definition of a *commercial tax return preparer*, you have New York State continuing education requirements. These requirements may not be satisfied with either CPE or CLE credits.

What your requirements are

There are two components to your required continuing education:

- free online continuing education courses, and
- a competency <u>exam</u>.

Course requirements

If you prepared **10 or more** New York State personal income tax returns or reports during 2014, 2015, and 2016, you **must** complete **four (4) hours** of continuing education coursework by the end of December 2018.

If you prepared **fewer than 10** New York State personal income tax returns during the years 2014, 2015, and 2016, you **must** complete:

- 16 hours of continuing education coursework by the end of December 2017, and
- 4 hours of continuing education coursework each year after that.

Note: If you complete the IRS course for tax preparers (Tax Return Preparer Certification), you cannot credit it toward your required New York State hours of coursework.

Competency exam requirement: When a competency exam becomes available, you have three years to complete and pass it. The Tax Department doesn't have any exams scheduled at this time.

Remember—if you don't meet the state's definition of a commercial tax return preparer, you are **not** required to complete continuing education courses. However, if you would still like to complete the courses, you may sign up for the Optional Learning Course in the SLMS, which contains each class offered to commercial tax return preparers.

How to complete your requirements

Course requirements

You'll need to complete your **free** online continuing education courses using the state's online Statewide Learning Management System (SLMS).

SLMS is an external website, but you must access it through your Tax Department Individual Online Services account to enroll in and complete your courses. Simply:

- 1. Log in to your Individual Online Services account.
- 2. Select *Tax preparer registration program* from the *Services* menu.
- 3. Select *Take required education* from the drop-down.
- 4. On the Registration and Continuing Education Training Tax Return Preparers page, select SLMS.
- 5. Enroll in and complete the appropriate courses. (See <u>How to use SLMS</u> to learn how.)
