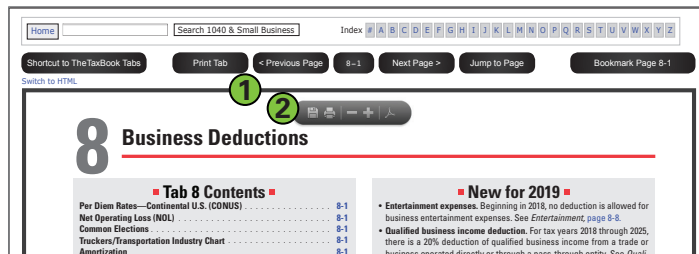

How to Print/Save a Single Page

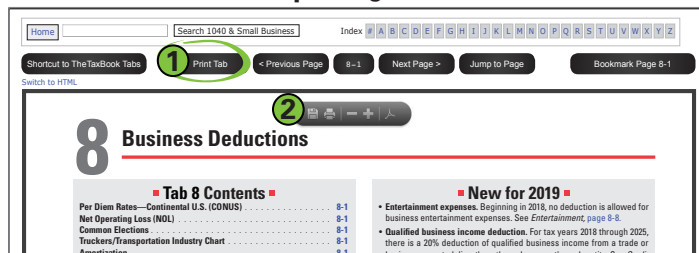


1 Hover your mouse over the top portion of the page and the gray Adobe tool bar will appear.

2 Click on either the Print or Save button.

1 Click on Print Tab. This will open a new window.

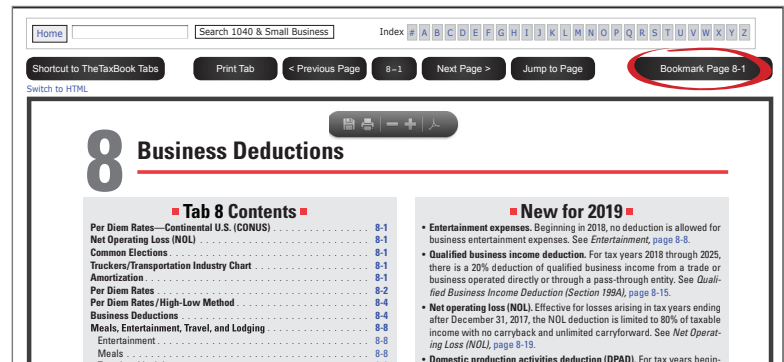
2 Click on either Print or Save.

Tip: Print the entire tab or indicate specific pages.

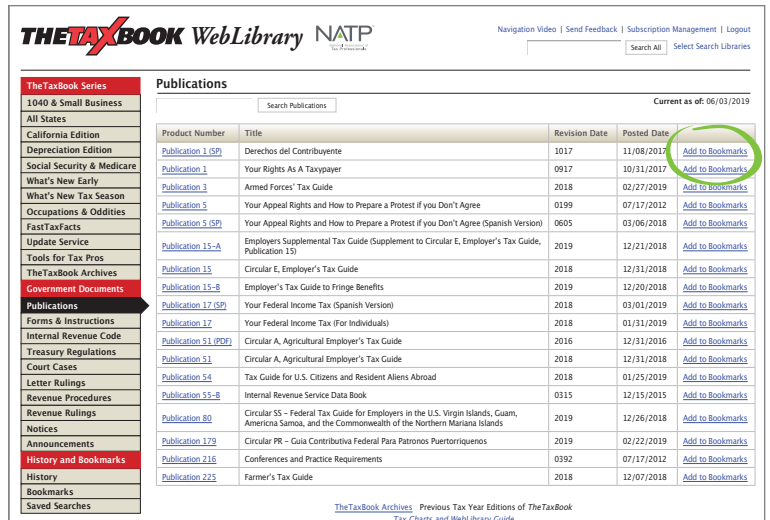
Bookmarks

Create bookmarks for frequently referenced pages. Bookmark function is available for both TheTaxBook Series and Government Documents.

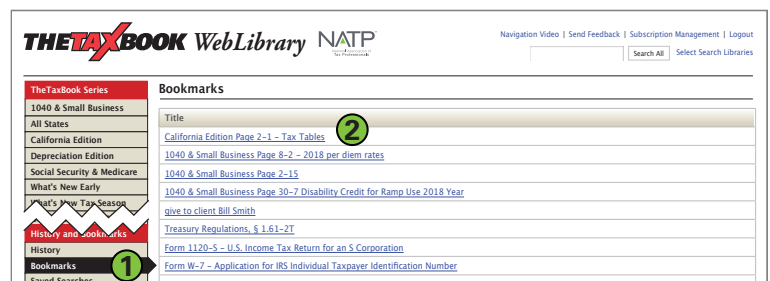
Bookmark a Page From TheTaxBook
