

# **Wisconsin NATP Chapter Scholarship Program**

The Wisconsin Chapter of NATP Scholarship Program will provide two ways to receive monetary funds to further your education in the tax preparation industry.

## **1) Scholarship for individuals who obtain the Enrolled Agent accreditation:**

The Wisconsin Chapter of NATP will provide a \$250 scholarship to any individual who has achieved accreditation as an Enrolled Agent.

To be eligible for the scholarship, you must meet the following requirements:

1. Must be a legal US citizen and Wisconsin resident
2. Must be an active member of the National Association of Tax Professionals (NATP) – Wisconsin Chapter.
3. You are a tax professional or accountant
4. Your completed application is received within 12 (twelve) months of receiving the Enrolled Agent accreditation

Applications will be reviewed and approved by the scholarship committee within ninety (90) days of receipt. Upon approval of your application, you will receive a check for \$250 from the Wisconsin Chapter of NATP.

## **2) Scholarship for attending Wisconsin NATP education seminars:**

The Wisconsin Chapter of NATP will have a drawing at the end of each educational seminar. All attendees of the seminar will be entered into the drawing. A winner will be drawn at the conclusion of the seminar and must be present to win. The winner will receive a certificate good for up to \$100 off a future seminar given by the Wisconsin Chapter of NATP. The certificate will be good for thirteen (13) months from the date of issue. The certificate can be redeemed by bringing it to the registration desk at the seminar of your choice.

These scholarships will be provided as available based on monetary balances in the scholarship fund.
