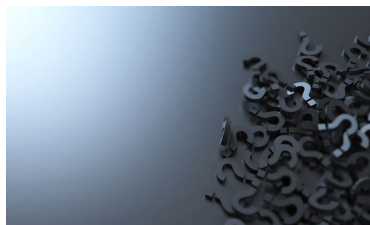

Texas Tax Tuesday Talks

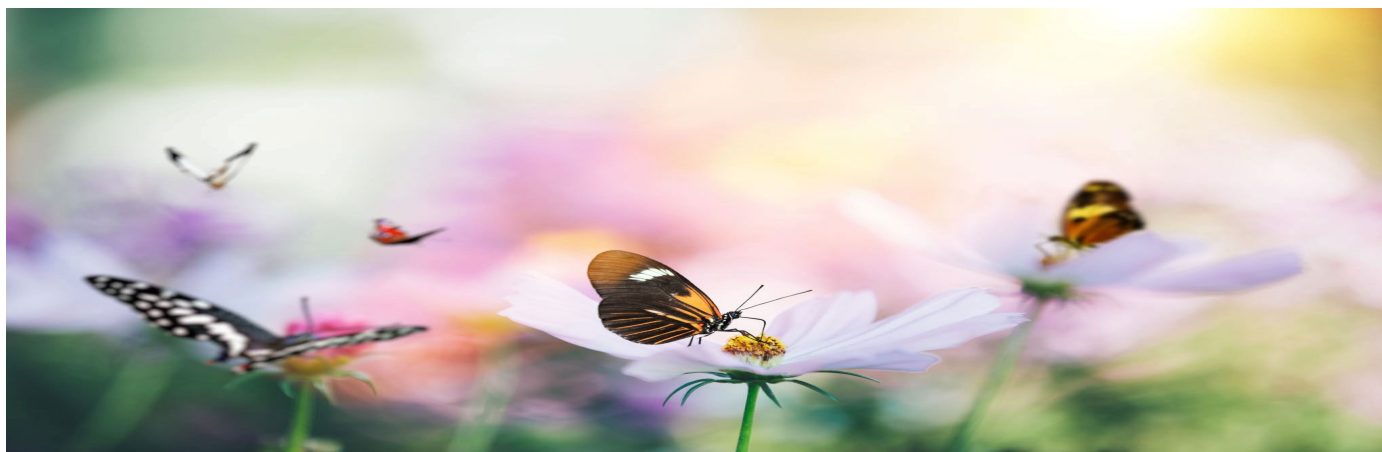
